BOARD OF TRUSTEES - GENERAL MEETING ANTELOPE VALLEY CEMETERY DISTRICT

WEDNESDAY, MAY 19, 2021, 2:00 P.M. via Zoom Conference MINUTES

- Call meeting to order by Chairman Owens at 2:00 p.m. with Trustees Richard Cook, Trustee Cynthia Poole, Manager/Board Secretary Dayle DeBry and two members of the public, Darlene Simpson and Alex Conedy, in attendance.
- No emergency items added to the agenda.
- 3. Comments from members of the public. Darlene Simpson, daughter of deceased, Audrey Conedy, regarding disposing of flowers after graveside service on May 3, 2021. E-mailed photos of flowers and price list for cost of flowers from Joshua Memorial Park (JMP). Flowers from funeral held four days prior on April 30, 2021 at JMP were not on grave after funeral as stated they would be by Office Asst. Was told they were thrown away because they were wilted. She saw them in the trash bin after they came back the next evening. How is this going to be rectified? They honored their mother with flowers. 1) Asking for a spray of white roses to be put at grave ½ of the original cost is \$595. 2) An apology. 3) Cemetery employees to be educated on clean-up policy/sensitivity training regarding grieving families.

Alex Conedy, son of deceased, Audrey Conedy: People can make mistakes but the cemetery employees showed no empathy, sympathy or professionalism. Flowers respect the grieving process. Family specifically asked Office Asst. if flowers would be placed on the grave with the grounds crew there as well. Flowers were missing and there were no other flowers in the trash bin. What is the cemetery policy on flowers? Someone needs to be fired.

D/O Apologized for what happened. AVCD is a public cemetery, not like JMP, a private facility, and payment with public funds cannot be decided at this meeting. A special meeting will have to be scheduled as soon as all Trustees can meet. D/D will contact all and schedule a Special Meeting as soon as possible. We (D/O) will contact you after the Special Meeting is held. A decision will be made then.

All Trustees and Manager apologized and gave their condolences to the family on the loss of their mother. Manager was out of town at the time of the incident.

 Unfinished Business: Office remodel. D/D will contact asbestos removal companies for three bids to begin removal process. Contact other entities for office operations while removal of asbestos is taking place.

 - B. Pine trees trimmed per City of Lancaster code enforcement- Katz at a cost of \$2,350. Semerenko cottonwood tree in History Section needs to be removed diseased and a safety hazard. Beekeeper coming out this week to look at hive in Semerenko tree. A large branch from an elm tree in the Pioneer Section fell due to high winds over the weekend. Tree is diseased and a safety hazard. Chad's Chippers will remove the cottonwood tree, elm tree and debris, and a small pine that is dying at a cost of \$7,000 for all three trees. Cottonwood will be cut an angle at the base so a plaque may be installed with the story of the historic tree. Leak at A-11 water main in Pioneer Section since Monday, 5/17. Plumber cannot fix until 5/21 at a cost of \$1,000. Other bids were \$4,500, \$2,500 and \$2,200.
